



ADMISSION PROCESS

APPLICATION DEADLINES

- Application deadlines: Numbers of places on the program are limited. The following admissions dates are guidelines. If the maximum class size is reached candidates will be placed on a waiting list or joined next semester.
- FOR THE PROGRAMME STARTING IN OCTOBER, FEBRUARY, JUNE **EACH YEAR**
- > Fall Semester: October each year
- Spring semester: February each year Summer semester: June each year

STEP 1

Individual assessment meeting with the admissions department (initial discussion in person, by phone or visioconference, with your programme advisor or another member of the admissions team).

STEP 2

The applications file will be made available to you following your initial discussion with your program advisor. When you apply for the Executive PhD, you will have to submit the following documents to

- please note that only complete applications will be reviewed:
- 1) Your personal details: name, address, e-mail, telephone number 2) Degree diplomas, and Executive
- certificates with grade transcripts 3) Up-to-date CV (Resume)
- 4) Two reference letters, ideally one from an individual who knows you in a professional context (e.g. current or former manager) and the other by a person of your choice, if possible from an academic context (e.g. a university professor)
- 5) English language certificate (for non-native English speakers only), TOEFL, TOEIC, IELTS 6) Copy of passport or ID
- 7) Application fee of Sfr.200 8) Purpose statement of enrollment:
- 1000~2000 words. ✓ Statement of purpose
- Your statement of purpose should address the following questions: Why do you want to do a (Fast-Track) Executive Ph.D. at this point in your career? What do you expect to acquire from the program? After graduation, what are your career aspirations post Executive Ph.D.? Please describe your previous experience of research, if any. What area of research are you interested in at this stage?
